1. The name of the Company is "GOLDEN CENTURY INTERNATIONAL HOLDINGS GROUP LIMITED (金禧國際控股集團有限公司)".

- 2. The Registered Office of the Company will be situate in the Colony of Hong Kong.
- 3. The objects for which the Company is established are:-
 - (1) To act as and to perform all the functions of a holding company and for that purpose to acquire and hold for investment shares, stock, debentures, debenture stock, bonds, obligations and securities issued or guaranteed by and company, and debentures, debenture stock, bonds, obligations and securities issued or guaranteed by any government, sovereign, ruler, commissioners, public body or authority, supreme, municipal, local or otherwise, whether at home or abroad, by original subscription, tender, purchase, exchange, underwriting, participation in syndicates or in any other manner and whether or not fully paid up, and to make payments thereon as called up or in advance of calls or otherwise and to subscribe for the same, either conditionally or absolutely, and to hold the same with a view to investment, but with power to vary any investments, and to exercise and enforce all rights and powers conferred by or incident to the ownership thereof, and to invest and deal with the moneys of the Company not immediately required upon such securities or deposits or otherwise and in such manner as may be from time to time determined.
 - (2) To purchase for investment land and buildings and other property of any tenure and any interest therein and to create freehold and leasehold ground rents and to let and grant leases and licences, to make arrangements with lessees and tenants and to acquire and grant easements and other rights and privileges and generally to lease and exchange land and house property and to acquire by purchase, lease, exchange or otherwise, lands and buildings of any tenure or description, whether situate in Hong Kong or elsewhere and any estate or interest or any easements, rights or privileges or concessions connected with any such lands or buildings and to advance money on mortgage securities.

- (3) To purchase, take on lease or in exchange, improve, mortgage, charge, rent, let on lease, hire, surrender, license, accept surrenders of, and otherwise acquire any freehold, leasehold or other property, chattels and effects, erect, pull down, repair, alter, develop or otherwise deal with any building or buildings and adapt the same for the purposes of investment or re-investment and to advance money to and enter into contracts and arrangements of all kinds with builders, tenants and others in connection therewith.
- (4) To carry on, acquire, undertake and execute any business, undertaking, transaction or operation whether manufacturing, financial, mercantile, agricultural, extractive, or otherwise and without prejudice to the generality of any of the foregoing objects to purchase, take on lease or in exchange, hire or otherwise acquire, and obtain options over, lands, buildings and generally any real or personal property, rights or privileges of any kind which the Company may deem necessary or convenient for or with reference to any of its objects, or capable of being profitably dealt with in connection with any of its property or rights for the time being.
- (5) To obtain vacant possession of any land, buildings, messuages, tenements and other erections belonging to the Company or in which the Company is interested either as owners, lessees, sub-lessees, contractors or otherwise whatsoever by proceedings in or applications to any court of law, tribunal or other appropriate authority having authority in that behalf or in any lawful manner, for the purpose of development or redevelopment by the erection of new buildings, tenements, messuages, houses or other erections and to pay compensation and other moneys to the lessees, tenants, sub-tenants and other occupiers thereof as may be ordered by the court, tribunal or appropriate authority or which may be otherwise payable.

- (12) To give, enter into and/or accept any guarantees or contracts of indemnity or suretyship (excluding fire and marine insurance business) and to guarantee, support or secure, either with or without the Company receiving any consideration or advantage therefor, and whether by personal covenant and/or by mortgage or charge upon all or any part of the undertaking, property or assets (present and future) of the Company (including its uncalled capital) and/or otherwise, the performance and discharge of the liabilities and obligations of every description of, and the payment and/or repayment of any moneys, (including premiums, interest, dividends and other moneys secured by or payable under any obligations or securities) by any person, firm or company including but not limited to any company which is (within the meaning of Section 2 of the Companies Ordinance (Chapter 32 of the laws of Hong Kong)) in relation to the Company, a subsidiary, a holding company or a subsidiary of such holding company or a predecessor in business of the Company. A statutory declaration in writing that the declarant is a Director or the Secretary of the Company, and that a share in the Company has been duly forfeited on a date stated in the declaration, shall be conclusive evidence of the facts therein stated as against all persons claiming to be entitled to the share.

LIEN

Company's lien 33. The Company shall have a first and paramount lien on every share (not being a fully paid share) for all moneys, whether immediately payable or not, called or payable at a fixed time in respect of such share. The Company shall also have a first and paramount lien on every share (not being a fully paid share) standing registered in the name of a member, whether singly or jointly with any other person or persons, for all the debts and liabilities of such member or his estate to the Company, and whether the same shall have been incurred before or after notice to the Company of any equitable or other interest of any person other than such member and whether the time for the payment or discharge of the same shall have actually arrived or not, and notwithstanding that the same are joint debts or liabilities of such member or his estate and any other person, whether a member of the Company or not. The Company's lien (if any) on a share shall extend to all dividends and other moneys payable thereon or in respect thereof. The Board may resolve that any share shall for some specified period be exempt from the provisions of this Article. Unless otherwise agreed, the registration of a transfer of any share shall operate as a waiver of the Company's lien (if any) on such share.

- Sale of shares 34. The Company may sell, in such manner as the Board think fit, any share on which the Company has a lien, but no sale shall be made unless and until some sum in respect of which the lien exists is immediately payable, nor until the expiration of fourteen days after a notice in writing, stating and demanding payment of such sum, and giving notice of intention to sell in default, shall have been given to the holder for the time being of the share or to the person entitled by reason of his death or bankruptcy to the share.
- 35. Application of The net proceeds of such sale, after payment of the costs of such sale, proceeds of shall be applied in or towards payment or satisfaction of any sum sale of shares immediately payable in respect whereof the lien exists, and any residue shall (subject to a like lien for such debts or liabilities in respect of moneys not immediately payable as existed on the share prior to the sale) be paid to the person entitled to the share at the time of the sale. For giving effect to any such sale the Board may authorise some person to transfer the share sold to the purchaser thereof. The purchaser shall be registered as the holder of the share so transferred and shall not be bound to see to the application of the purchase money, nor shall his title to the share be affected by any irregularity or invalidity in the proceedings in reference to the sale.

UNTRACEABLE MEMBERS

Power to sell 36. (A) The Board may by resolution at any time declare that any member shares of untraceable members 36. (A) The Board may by resolution at any time declare that any member be deemed to be an untraceable member (as hereinafter defined) and may at any time within three months thereafter sell all or any of the shares registered in the name of such member, on behalf of such member or any person entitled to such shares in consequence of the death or bankruptcy of such member, at the best price reasonably obtainable at the time of the sale.

- (B) To give effect to any such sale, the Board may, notwithstanding anything elsewhere in these Articles contained, authorise some person to execute on behalf of the untraceable member a transfer in favour of the purchaser and upon receipt by the Company of the purchase money the Company shall cause the name of the purchaser to be entered in the Register as the holder of the shares but so that notwithstanding the provisions of Article 39(A)(i) hereof the Board shall not be bound to require the production or deposit of any share certificate. After the purchaser's name has been entered in the Register in the purported exercise of the power conferred by this Article, the validity of the proceedings shall not be questioned by any person. The purchase money shall be carried to a separate account and shall constitute a permanent debt of the Company. Such money shall until payment over to the untraceable member or such other person as aforesaid be available to the Company for its own use free of interest and without any liability to account for any profit arising therefrom.
- (C) For the purpose of this Article, a member shall be deemed to be an untraceable member if:-
 - (i) his name is entered in the Register; and
 - (ii) during the period of twelve years immediately preceding the date of the resolution of the Board referred to in paragraph (A) of this Article no cheque or warrant sent by the Company through the post addressed to the member at his registered address or to the person entitled by transmission at the address shown in the Register as his address or otherwise the last known address given by the member or the person entitled by transmission to which cheques and warrants are to be sent has been cashed and no communication has been received by the Company from the member or person entitled by transmission provided that in any such period of twelve years the Company has paid at least three dividends whether interim or final and no such dividend has been claimed; and

- (iii) the Company has at the expiration of the said period of twelve years given notice by advertisement in accordance with these Articles of its intention to sell the shares of such member; and
- (iv) the Company has not during the further period of three months after the date of the advertisement and prior to the exercise of the power of sale received any communication from the member or person entitled by transmission; and
- (v) for so long as any share capital of the Company is listed on any stock exchange in Hong Kong, notice shall have been given to such stock exchange of the Company's intention to sell the shares of such member.

For all the purposes of this Article, a statutory declaration by the Secretary in relation to any member to the effect that the foregoing provisions of this paragraph (C) have been satisfied shall be conclusive and binding on the Company and the member concerned and all persons claiming through or under him.

TRANSFER OF SHARES

Form and execution of transfer 37. Shares in the Company shall be transferred by instrument of transfer in any usual or common form, or in such other form as shall be approved by the Board. The instrument of transfer of a share (which need not be under seal) shall be signed by or on behalf of the transferor and the transferee, and the transferor shall be deemed to remain the holder of the share until the name of the transferee is entered in the Register in respect thereof. Where the transferor or the transferee is HKSCC Nominees Limited (or such other company as may be approved by the Board for this purpose) the instrument of transfer of a share may be executed by machine imprinted signature on its behalf. (As altered by Special Resolution passed on 13 June 1996)

The Board's 38. The Board may in their discretion, and without assigning any reason power to decline to register a transfer of any share which is not fully paid up.

(ii) the instrument of transfer is in respect of only one class of shares; and
(iii) the instrument of transfer is in favour of not more than four joint holders; and

- (B) If the Board decline to register a transfer of any share, they shall, within two months after the date on which the transfer was lodged with the Company, send to the transferor and the transferee notice of the refusal. If any of the transferor or transferee should request a statement of the reasons for the refusal, the Board must, within twenty-eight days after receipt of the request, send a statement of the reasons or the Board may instead register the transfer.
- Fee payable 40. The Company may in respect of the registration of any transfer, probate, letters of administration, certificate of marriage or death, power of attorney, stop notice, order of court or other document relating to or affecting the title to any share charge a fee not exceeding, in the case of any share capital listed on <u>a-the S</u>stock <u>E</u>exchange-<u>in Hong Kong</u>, two Hong Kong dollars or such greater sum as such stock exchange may from time to time permit and, in the case of any other share capital, such reasonable sum as the Board may from time to time determine.

- Suspension of 41. The registration of transfers may be suspended at such times and for such periods as the Board may from time to time determine, and either generally or in respect of any class of shares, provided always that such registration shall not be suspended for more than thirty days in any calendar year and such thirty-days' period may be extended if approved by an Ordinary Resolution passed by the Company in that calendar year in accordance with the Statutes.
- 42. All instruments of transfer which are registered may be retained by the Power to destroy Company.  - (i) The provisions aforesaid shall apply only to the destruction of a document in good faith and without notice of any claim (regardless of the parties thereto) to which the document might be relevant.
 - (ii) Nothing herein contained shall be construed as imposing upon the Company any liability in respect of the destruction of any document earlier than as aforesaid or in any other circumstances which would not attach to the Company in the absence of this Article.
 - (iii) References herein to the destruction of any document include references to the disposal thereof in any manner.
- Renunciation 43. Nothing in these Articles contained shall preclude the Board from recognising renunciation of any share by the allottee thereof in favour of some other person.

TRANSMISSION OF SHARES

- Transmission 44. In the case of the death of a member, the survivors or survivor where the deceased was a joint holder, and the legal personal representatives of the deceased where he was a sole or only surviving holder, shall be the only persons recognised by the Company as having any title to his interest in any share; but nothing contained in this Article shall release the estate of a deceased joint holder from any liability in respect of any share which had been jointly held by him with any other person.
- Registration of 45. Any person becoming entitled to a share in consequence of the death or bankruptcy of any member may, upon such evidence of his title being produced as may from time to time be required by the Board (but subject to the provisions hereinafter contained), elect either to be registered himself as a member in respect of the share or to have some person nominated by him registered as transferee thereof.
- Election for 46. If the person so becoming entitled shall elect to be registered himself, he shall deliver or send to the Company a notice in writing signed by him stating that he so elects. - Resolution 65. (A) When by any provision contained in the Statutes special notice is required of a resolution, the resolution shall not be effective unless notice of the intention to move it has been given to the Company not less than twenty-eight days (or such shorter period as the Statutes may allow) before the meeting at which it is moved, and the Company shall give to the members notice of any such resolution as required by and in accordance with the provisions of the Statutes.
- Amendment to Resolutions
 (B) In the case of a resolution duly proposed as a Special Resolution no amendment thereto (other than a mere clerical amendment to correct a patent error) may in any event be considered or voted upon. If within half an hour after the time appointed for the meeting a quorum not present is not present, the meeting, if convened by or upon the requisition of members, shall be dissolved. If otherwise convened it shall stand adjourned to the same day in the next week (or if that day be a public holiday, then to the next business day following such public holiday), at the same time and place or to such other day and at such other time and place as the Board may determine and no notice of such adjournment need be given. If at such adjourned meeting a quorum is not present within fifteen minutes from the time appointed for the meeting, the meeting shall be dissolved.

 - (ii) when a meeting is postponed in accordance with this Article, the Board shall fix the date, time and place for the reconvened meeting and seven clear days' notice at the least of the reconvened meeting shall be given by one of the means specified in Article 152 and shall specify the date, time and place at which the postponed meeting will be reconvened, and the date and time by which proxies shall be submitted in order to be valid at such reconvened meeting (provided that any proxy submitted for the original meeting shall continue to be valid for the reconvened meeting unless revoked or replaced by a new proxy); and
 - (iii) notice of the business to be transacted at the reconvened meeting shall not be required, nor shall any accompanying documents be required to be recirculated, provided that the business to be transacted at the reconvened meeting is the same as that set out in the original notice of General Meeting circulated to the members of the Company.

FULL TERMS OF THE NEW ARTICLES

Voting shall be
by poll70.A resolution put to the vote at a General Meeting shall be decided by way
of a poll save that the Chairman of the meeting may in good faith, allow
a resolution which relates to a purely procedural or administrative matter

person or by proxy(ies) shall have one vote provided that where more
than one proxy is appointed by a member which is a Clearing House (or
its nominee(s)), each such proxy shall have one vote on a show of hands.
For the purposes of this Article, procedural and administrative matters are
those set out in the Listing Rules.

Method of voting 70<u>A</u>. Where the Chairman allows a resolution which relates to a purely procedural or administrative matter to be voted on by a show of hands, a poll may be demanded (before or upon the declaration of the result of the show of hands) by Every question submitted to a General Meeting shall be determined in the first instance by a show of hands of the members present in person, but a poll may be demanded (before or upon the declaration of the result of the show of hands) by the Chairman or by:-

- (A) not less than three members present in person or by proxy having the right to vote at the meeting; or
- (B) a member or members present in person or by proxy representing not less than one-tenth-twentieth of the total voting rights of all the members having the right to vote at the meeting; or
- (C) a member or members present in person or by proxy holding shares conferring a right to vote at the meeting, being shares on which an aggregate sum has been paid up equal to not less than one-<u>twentieth</u> tenth of the total sum paid up on all the shares conferring that right.
- Recording of Unless a poll is duly demanded in accordance with the foregoing provisions a declaration by the Chairman that a resolution has been carried or lost or has or has not been carried by any particular majority, and an entry to that effect in the proceedings of the Company, shall be conclusive evidence of the fact without proof of the number, proportion or validity of the vote recorded in favour of or against such resolution.

Objections 71. If:-

- (A) any objection is raised to the qualification of any voter; or
- (B) any votes are counted which ought not to have been counted or which might have been rejected; or
- (C) any votes are not counted which ought to have been counted;

the objection or error shall not vitiate the decision of the meeting on any resolution unless the same is raised or pointed out at the meeting or adjourned meeting <u>or postponed meeting</u> at which the vote objected to is given or tendered or at which the error occurs. Any objection or error shall be referred to the Chairman of the meeting and shall only vitiate the decision of the meeting on any resolution if the Chairman decides that the same may have affected the decision of the meeting. The decision of the Chairman on such matters shall be final and conclusive.

- How poll to be 72. If aA poll is duly demanded it shall be taken in such manner as the taken Chairman may direct (including the use of ballot or voting papers or tickets) and the result of a poll shall be deemed to be the resolution of the meeting at which the poll was demanded. The Chairman may appoint scrutineers for the purposes of a poll, and may either (i) declare the result of the poll at the meeting; or (ii) adjourn the meeting to some place and time fixed by him for the purpose of declaring the result of a poll; or (iii) determine that the results of the poll, if certified by any Director or the Company Secretary, shall be published on the Company's website without the requirement for the results being declared at any meeting or adjourned meeting or postponed meeting, and any such declaration at a meeting or an adjourned meeting or publication on the Company's website of the results of the relevant poll which shows that a resolution has been carried or lost or has or has not been carried by any particular majority, and an entry to that effect in the minutes of the proceedings of the Company, shall, in the absence of manifest error, be conclusive evidence of such fact.
- Time for taking 73. A poll demanded on the election of a Chairman or on a question of a djournment shall be taken at once. A poll demanded on any other question shall be taken either at once or at such time and place as the Chairman directs not being more than thirty days from the date of the meeting or adjourned meeting or postponed meeting at which the poll was demanded. No notice need be given of a poll not taken immediately.
- Continuance of 74. The demand for a poll shall not prevent the continuance of a meeting for the transaction of any business other than the question on which the poll has been demanded.
- Withdrawal of 75. The demand for a poll may be withdrawn but only with the consent of the Chairman and a demand so withdrawn shall not be taken to have invalidated the result of a show of hands declared before the demand was made.

Chairman's 76. In case of an equality of votes, whether on a show of hands or in a poll, the Chairman of the meeting at which the show of hands takes place or at which the poll is demanded, as the case may be, shall have a second or casting vote.

- Voting rights 77. Subject to any special rights or restrictions as to voting attached to any shares by or in accordance with these Articles, on a show of hands every member who (being an individual) is present in person or by proxy or (being a corporation) is represented by proxy or in accordance with the Statutes shall (i) on a show of hands have one vote (except as provided below); and (ii) on a poll have one vote for every share held by him or it provided that if a member appoints more than one proxy, the proxies so appointed are not and on a poll every member present in person or by proxy shall have one vote for every share held by him.entitled to vote on the resolution on a show of hands.
- Corporate 78. (A) Any corporation which is a member of the Company may, by resolution of its Directors or other governing body, authorise such person as it thinks fit to act as its representative at any meeting of the Company, or at any meeting of any class of members of the Company, and the person so authorised shall be entitled to exercise the same powers on behalf of the corporation which he represents as that corporation could exercise if it were an individual member of the Company and references in these Articles to a member present in person at a meeting shall, unless the context otherwise requires, include a corporation which is a member represented at the meeting by such duly authorised representative. (As altered by Special Resolution passed on 13 June 1996)

- (B) If a recognised the Celearing Hhouse within the meaning of section 2 of the Securities and Futures Ordinance (Chapter 571 of the laws of Hong Kong) is a member of the Company, it may authorise by resolution of its board of directors or other governing body such person or persons as it thinks fit to act as its representative (or representatives) at any meeting of shareholders or at any meeting of any class of shareholders provided that, if more than one person is so authorised, the authorisation must specify the number and class of shares in respect of which each such person is so authorised. A person so authorised in respect of all or part of the shareholding of the a recognised Celearing Hhouse will be entitled to exercise the same powers on behalf of the recognised cClearing Hhouse which he represents as that Celearing Hhouse could exercise if it were an individual shareholder who held such shares and no other shares in the Company. (As inserted by Special Resolution passed on 13 June 1996 and altered by Special Resolution passed on 31 May 2004)
- Abstention(C)Where any member, under the Listing <u>Rrules or the rules, codes or regulations of any competent regulatory authority of the Stock Exchange</u>, is required to abstain from voting on any particular resolution or is restricted to voting only for or only against any particular resolution, any votes cast by or on behalf of such member in contravention of such requirement or restriction shall not be counted. (As inserted by Special Resolution passed on 31 May 2004)
- Voting rights of 79. Where there are joint holders of any share, any one of such persons may vote at any meeting, either personally or by proxy, in respect of such share as if he were solely entitled thereto <u>p</u>Provided that if more than one of such joint holders be present at any meeting personally or by proxy, the person whose name stands first in the Register in respect of such share shall alone be entitled to vote in respect thereof.
- 80. Members of A member of unsound mind, or who is a patient for the purposes of any unsound mind legislation relating to mental health, or in respect of whom an order has been made by any court (whether in Hong Kong or elsewhere) having jurisdiction in lunacy, may vote, whether on a show of hands or on a poll by his committee, receiver, curator bonis, or other person in the like nature appointed by such court, who may themselves vote on a poll by proxy pProvided that such evidence as the Board may require of the authority of the person claiming to vote shall have been deposited at the Office or at such other place as is specified in accordance with these Articles for the deposit of instruments of proxy not less than forty-eight hours before the time for holding the meeting or adjourned meeting or postponed meeting at which such person claims to vote and in default the right to vote shall not be exercisable.

FULL TERMS OF THE NEW ARTICLES

- No right to vote unless calls paid 81. No member shall, unless the Board otherwise determine, be entitled in respect of shares held by him to vote at a General Meeting or meeting of the holders of any class of shares of the Company either personally or by proxy or to exercise any other right conferred by membership in relation to meetings of the Company or of the holders of any class of shares of the Company if any call or other sum presently payable by him to the Company in respect of such shares remains unpaid.
- Polls 82. On a poll votes may be given either personally or by proxy and a member entitled to more than one vote need not, if he votes on a poll, use all his votes or cast all the votes he uses in the same way.
- Proxies need 83. A member may appoint more than one proxy to attend on the same occasion. A proxy need not be a member of the Company. A proxy so appointed shall also have the same right as the member to participate in the business of the meeting.
- Execution of proxies 84. Every instrument appointing a proxy shall be in writing under the hand of the appointor or of his attorney duly authorised in writing or, if such appointor is a corporation, under its common seal or under the hand of some officer of the corporation duly authorised in that behalf. In the case of an instrument of proxy purporting to be signed on behalf of a corporation by an officer thereof it shall be assumed, unless the contrary appears, that such officer was duly authorised to sign such instrument of proxy on behalf of the corporation without further evidence of the fact.
- Deposit of 85. The instrument appointing a proxy and, if required by the Company, the proxies power of attorney or other authority (if any) under which it is signed or a notarially certified copy or office copy of such power or authority, shall be deposited at the Office or at such other place within Hong Kong as is specified for that purpose in the notice convening the meeting or in any instrument of proxy sent by the Company in relation to the meeting, not less than forty-eight hours before the time appointed for holding the meeting or adjourned meeting or postponed meeting, as the case may be, at which the person named as proxy in such instrument proposes to vote, or, in the case of a poll, not less than twenty-four hours before the time appointed for the taking of the poll; and in default the instrument of proxy shall not be treated as valid Provided that an instrument of proxy relating to more than one meeting (including any adjournment thereof) having once been so delivered for the purposes of any meeting shall not require again to be delivered for the purpose of any subsequent meeting to which it relates.

- Expiration of 86. No instrument appointing a proxy shall be valid after the expiration of twelve months from the date of its execution, except at an adjourned meeting or on a poll demanded at a meeting or an adjourned meeting in cases where the meeting was originally held within twelve months from such date.
- Form of and authority of proxies 87. Instruments of proxy shall be in any common from or in such other form as the Board may approve. The instrument of proxy, which need not be witnessed, shall be deemed to confer authority to demand or join in demanding a poll and to vote on any amendment of a resolution put to the meeting for which it is given as the proxy thinks fit. The instrument of proxy shall, unless the contrary is stated therein, be valid as well for any adjournment of the meeting as for the meeting to which it relates.
- Board to send 88. (A) The Board shall at the expense of the Company send with all notices proxies to all voting members (A) The Board shall at the expense of the Company send with all notices convening General Meetings or meetings of any class of members of the Company to the members entitled to vote thereat instruments of proxy (with or without prepaid postage) with provision for two-way voting on all resolutions intended to be proposed other than resolutions <u>raised at the meeting</u> which are merely procedural—or relate to the fixing of Auditors' remuneration.
 - (B) Such instruments of proxy shall be issued to all the members entitled to be sent a notice of the meeting and to vote thereat by proxy, and not to some only of such members.
 - (C) The accidental omission to send out an instrument of proxy, whenever necessary, to any member or the non-receipt of such instrument by any member, shall not invalidate any resolution passed or proceedings at the meeting to which the instrument of proxy relates.
- Determination 89. A vote given or poll demanded by proxy or by the duly authorised representative of a corporation shall be valid notwithstanding the previous determination of the authority of the person voting or demanding a poll provided that no notice in writing of such determination shall have been received by the Company at the Office (or at such other place within Hong Kong as is specified for the deposit of instruments of proxy in accordance with these Articles) before the commencement of the meeting or adjourned meeting or postponed meeting_at which the vote is given or the poll demanded or (in the case of a poll taken otherwise than on the same day as the meeting or adjourned meeting or postponed meeting_ or postponed meeting) the time appointed for taking the poll.

DIRECTORS

- Number of 90. Unless and until otherwise determined by the Company by Ordinary Directors Resolution the number of Directors shall not be less than two and there shall be no maximum number of Directors. (As altered by Special Resolution passed on 20 May 2013)
- Qualification of 91. A Director shall not be required to hold any shares of the Company by Directors; rights at meetings A Director shall not be required to hold any shares of the Company shall nevertheless be entitled to attend and speak at General Meetings or meetings of the holders of any class of shares. Directors may participate in any General Meeting by means of a conference telephone, electronic or other communications equipment through which all persons participating in the meeting can communicate with each other simultaneously and instantaneously and, such participating were present in person.

FULL TERMS OF THE NEW ARTICLES

Alternate Directors

- 92. Any Director (other than an alternate Director) may at any time and from time to time appoint any other Director or appoint any other person approved by a majority of the other Directors for the time being to be his alternate, and may at any time remove any alternate Director appointed by him and (subject to such approval as aforesaid) appoint another in his place. An alternate Director shall not be entitled to receive any remuneration from the Company, nor shall it be necessary for him to acquire or hold any share qualification, but he shall be entitled (subject to his giving to the Company an address within Hong Kong at which notices may be served on him) to receive notices of meetings of the Directors and to attend and vote as a Director at any such meeting at which the Director appointing him is not present, and generally at such meeting to exercise all the powers, rights, duties and authorities of the Director appointing him. A Director who is also an alternate Director shall be entitled in addition to his own vote to a separate vote on behalf of the Director appointing him. An alternate Director may be removed from office by a resolution of the Board, and shall ipso facto cease to be an alternate Director if his appointor ceases for any reason to be a Director Provided that if any Director retires at a General Meeting but is re-elected by the meeting or is, pursuant to the provisions of these Articles, deemed to be re-elected at the meeting at which such retirement took effect, any appointment made by him pursuant to this Article which was in force immediately prior to his retirement shall continue to operate after such re-election as if he had not so retired. Every person acting as an alternate Director shall be an officer of the Company, and, without prejudice to any liability which he may cause to his appointor under the Statutes or otherwise, shall be responsible to the Company for his acts and defaults, and he shall be deemed to be the agent of or for the Director appointing him. All appointments and removals of alternate Directors made by any Director in pursuance of this Article shall be in writing under the hand of the Director making the same and shall be sent to or left at the Office. (As altered by Special Resolution passed on 31 May 2004)
- Remuneration 93. The remuneration of the Directors shall be such sum or sums as the Company may in General Meeting from time to time determine. The Directors' remuneration shall be deemed to accrue from day to day. (As altered by Special Resolution passed on 20 May 2013)
- Directors' 94. The Directors shall be entitled to be paid all travelling, hotel and other expenses of their duties or in attending General Meetings or meetings of the Board or Committees of the Board.

FULL TERMS OF THE NEW ARTICLES

- Further 95. If any Director, being willing and having been called upon to do so, shall render or perform extra or special services of any kind including services on any Committee of the Board or shall travel or reside abroad for any business or purposes of the Company, he shall be entitled to receive such sum as the Board may think fit for expenses, and also such remuneration as the Board may think fit either as a fixed sum or as a percentage of profits or otherwise, and such remuneration may, as the Board shall determine, be either in addition to or in substitution for any other remuneration he may be entitled to receive, and the same shall be charged as part of the ordinary working expenses of the Company.
- Vacation of 96. (A) Without prejudice to the provisions for retirement by rotation office hereinafter contained, the office of a Director shall be vacated in any of the events following, namely:-
 - (i) if he resigns his office by notice in writing delivered to the Office or submitted to a meeting of the Board;
 - (ii) if he becomes of unsound mind or a patient for the purposes of any legislation (whether in Hong Kong or elsewhere) relating to mental health and the Board resolve that his office be vacated;
 - (iii) if, without leave, he is absent from meetings of the Board (whether or not any alternate Director appointed by him attends) for six consecutive months, and the Board resolve that his office be vacated;
 - (iv) if <u>behe</u> becomes bankrupt or makes any arrangement or composition with his creditors generally;
 - (v) if he is prohibited by law from being a Director;
 - (vi) if he ceases to be a Director by virtue of the Statutes or is removed from office pursuant to these Articles;
 - (vii) if all the other Directors unanimously resolve that he be removed as a Director.
 - (B) No Director shall be required to vacate office or be ineligible for reelection or re-appointment as a Director, and no person shall be ineligible for appointment as a Director, by reason only of his having attained any particular age.

(A) If a Director or any of his <u>close</u> associates is in any way, whether directly or indirectly, interested in a contract, transaction or arrangement or proposed contract, transaction or arrangement with the Company (each being in paragraphs (A), (B) and (C) of this Article referred to as a "transaction"), the Director shall declare the nature of his interest or the interest of any of his <u>close</u> associates at a meeting of the Board in accordance with the Statutes and any applicable rules, codes and regulations of the Stock Exchange and/or of any relevant regulatory body. For the purposes of this Article:-
 - (i) a general notice given to the Directors by a Director stating that, by reason of facts specified in the notice, he or any of his <u>close</u> associates is to be regarded as interested in transactions of any description which may subsequently be made with any specified person, firm or corporation after the date of such notice shall be a sufficient declaration of his interest or the interest of any of his <u>close</u> associates, so far as attributable to those facts, in relation to any transaction of that description which may subsequently be made by the Company <u>p</u>Provided that no such general notice shall have effect in relation to any transaction unless it is given before the date on which the question of entering into the transaction is first taken into consideration on behalf of the Company; and
 - (ii) an interest of which a Director has no knowledge and of which it is unreasonable to expect him to have knowledge shall not be treated as an interest of his or of any of his <u>close</u> associates. (As altered by Special Resolution passed on 31 May 2004)

Interested Directors not entitled to vote

 - (a) to the Director or his close associate(s) in respect of money lent or obligations incurred or undertaken by him or any of them at the request of or for the benefit of the Company or any of its subsidiaries; orthe adoption, modification or operation of any employees' share scheme or any share incentive or share option scheme under which the Director or any of his associates may benefit; or

(b) to a third party in respect of a debt or obligation of the Company or any of its subsidiaries for which the Director or his close associate(s) has himself/themselves assumed responsibility in whole or in part and whether alone or jointly under a guarantee or indemnity or by the giving of <u>security</u>: the adoption, modification or operation of a pension fund or retirement, death or disability benefits scheme;

which relates both to Directors, their associates and employees of the Company or any of its subsidiaries and does not provide in respect of any Director, or any of his associates, as such any privilege or advantage which may not generally be accorded to the class of persons to which such scheme or fund relates; or

- (viii) any proposal concerning an offer of shares or debentures or other securities of or by the Company or any other company which the Company may promote or be interested in for subscription or purchase where the Director or his close associate(s) is/are or is/are to be interested as a participant in the underwriting or sub-underwriting of the offer;any contract or arrangement in which the Director or any of his associates is interested in the same manner as other holders of shares or debentures or other securities of the Company by virtue only of his or their interest in shares or debentures or other securities of the Company;
- (iii) any proposal or arrangement concerning the benefit of employees of the Company or its subsidiaries including:

- (E) If any question shall arise at any meeting of the Board as to the materiality of the interest of a Director (other than the chairman of the meeting) or his close associate(s) or as to the entitlement of any Director (other than such chairman) to vote or be counted in the quorum and such question is not resolved by his voluntarily agreeing to abstain from voting or not to be counted in the quorum, such question shall be referred to the chairman of the meeting and his ruling in relation to such other Director or his close associate(s) shall be final and conclusive except in a case where the nature or extent of the interest of the Director or his close associate(s) concerned as known to such Director has not been fairly disclosed to the Board. If any question as aforesaid shall arise in respect of the chairman of the meeting or his close associate(s) such question shall be decided by a resolution of the Board (for which purpose such chairman and any of the other directors present who are materially interested in the contract or arrangement in question shall be counted in the quorum but shall not vote thereon) and such resolution shall be final and conclusive except in a case where the nature or extent of the interest of such chairman or his close associate(s) as known to such chairman has not been fairly disclosed to the Board. - (F) Subject to the provisions of the Statutes a Director may hold any other office or place of profit under the Company (other than the office of Auditor) in conjunction with his office of Director for such period and on such terms (as to remuneration and otherwise) as the Board may determine and no Director or intended Director shall be disqualified by his office from contracting with the Company either with regard to his tenure or the tenure of any of his close associates of any such other office or place of profit or as vendor, purchaser or otherwise, nor shall any such contract or any contract or arrangement entered into by or on behalf of the Company in which any Director or any of his close associates is in any way interested, be liable to be avoided, nor shall any Director so contracting or being so interested be liable to account to the Company for any profit realised by any such contract or arrangement by reason of such Director or any of his close associates holding that office or of the fiduciary relationship thereby established. provisions of the Statutes of all charges specifically affecting property of

To manage The business of the Company shall be managed by the Board, who may Company's exercise all such powers of the Company and do on behalf of the business Company all such acts as are within the scope of the Memorandum and these Articles of Association of the Company and as are not, by the Statutes or by these Articles, required to be exercised or done by the Company in General Meeting, subject, nevertheless, to the provisions of the Statutes and to these Articles and to such directions, being not inconsistent with the said provisions and these Articles, as may be prescribed by the Company in General Meeting, but so that no such direction and no alteration to these Articles shall invalidate any prior act of the Board which would have been valid if that direction or alteration had not been given or made.
- 102. To provide The Board on behalf of the Company may pay a gratuity or pension or pensions for allowance on retirement to any Director or former Director who has held Directors any salaried office or place of profit with the Company or with any body corporate which is or has been in relation to the Company a subsidiary or a holding company or a subsidiary of such holding company or a predecessor in business of the Company or of any such subsidiary or holding company or subsidiary of such holding company or to any member of his family (including a spouse or former spouse) or to any person who is or was dependent on him and may (as well before as after he ceases to hold such office or place of profit) make contributions to any fund and pay premiums for the purchase or provision of any such gratuity, pension or allowance and may make payments for or towards the provision by means of insurance or otherwise of benefits for any such person.

FULL TERMS OF THE NEW ARTICLES

- 103. ROTATION RETIREMENT AND REMOVAL OF DIRECTORS

- Retirement of 104. Subject to the provisions of these Articles, at the Annual General Meeting Directors 104. Subject to the provisions of these Articles, at the Annual General Meeting in each year one-third of the Directors for the time being, or if their number is not three or a multiple of three, then the number nearest to but greater than one-third, shall retire from office. A retiring Director shall retain office until the conclusion of the meeting or adjourned meeting or postponed meeting_at which he is due to retire. - Selection of 105. (As altered by Special Resolution passed on 31 May 2004)

EXECUTIVE DIRECTORS

- 113. Board's power (A) The Board may from time to time appoint one or more of their number to be the holder of any executive office (including that of Chairman or Deputy Chairman) on such terms and for such period as they think fit and, subject to the terms of any contract between him and the Company, may at any time revoke any such appointment. A Director appointed as Chairman or Deputy Chairman shall be subject to the same provisions as to rotation, resignation and removal as the other Directors.  - (B) The appointment of any Director as Chairman or Deputy Chairman shall automatically determine if he ceases to be a Director but without prejudice to any claim for damages for breach of any contract between him and the Company. (As altered by Special Resolution passed on 20 May 2013)
 - (C) A Director may only be removed from his office as Chairman or Deputy Chairman by a resolution of the Directors passed by two-thirds in number of the Directors from time to time. (As inserted by Special Resolution passed on 20 May 2013)
- 114. Remuneration The remuneration of an executive Director shall be fixed by the Board and may be by way of salary or commission or participation in the profits, or by any or all of those modes or otherwise.
- Delegation 115. The Board may entrust to and confer upon any executive Director any of the powers, authorities and discretions exercisable by them as Directors, other than the power to make calls or forfeit shares, upon such terms and conditions and with such restrictions as they think fit, and either collaterally with or to the exclusion of their own powers and may from time to time revoke, withdraw, alter or vary all or any of such powers.

ASSOCIATE DIRECTORS

Board's power 116. PROCEEDINGS OF THE BOARD

- Meetings 117. The Board may meet together for the despatch of business, adjourn, and otherwise regulate their meetings and proceedings as they think fit and determine the quorum necessary for the transaction of business. Until otherwise determined two directors shall be a quorum. A person who holds office only as an alternate shall if his appointor is not present be counted in the quorum. Questions arising at any meeting of the Board shall be decided by a majority of votes. In case of an equality of votes, the Chairman shall have a second or casting vote.
- Votes Members of the Board or of any Committee thereof may participate in a meeting of the Board or of such Committee by means of conference telephone or similar communications equipment <u>or other electronic means</u> by means of which all persons participating in the meeting can hear <u>and speak to</u> each other and participation in a meeting pursuant to this provision shall constitute presence in person at such meeting. Such a meeting shall be deemed to take place where the largest group of those participating is assembled, or, if there is no such group, where the Chairman of the meeting is then present.
- Proceedings in 118. The continuing Directors may act notwithstanding any vacancy in their case of vacancies body Provided that in case the Directors shall at any time be reduced in number to less than the minimum number fixed by or in accordance with these Articles, it shall be lawful for the continuing Director or Directors to act for the purpose of filling vacancies or summoning a General Meeting, but not for any other purpose.
- Calling of 119. A Director may, and on the request of a Director the Secretary shall, at any time summon a meeting of the Board. It shall not be necessary to give notice of a meeting of the Board to any Director for the time being absent from Hong Kong. Notice of a meeting of the Board may be given in any manner, including in writing or by cable or telex or facsimile transmission or via electronic mail or by telephone or otherwise orally. A Director may waive notice of any meeting and any such waiver may be retrospective. A resolution of the Board shall not be deemed to be invalid by reason only that notice of the resolution was not given in the notice of the meeting at which it was passed. (As altered by Special Resolution passed on 20 May 2013)

- Chairman 120. The Board may from time to time elect a Chairman and Deputy Chairman of the Board and determine the period for which they are respectively to hold office. The Chairman so elected, or in his absence the Deputy Chairman, shall preside at all meetings of the Board, but if no such Chairman or Deputy Chairman be elected, or if at any meeting the Chairman or Deputy Chairman be not present within five minutes after the time appointed for holding the same, the Directors present shall choose one of their number to act as Chairman of such meeting.
- Quorum of
Directors may121.A meeting of the Board at which a quorum is present shall be competent
to exercise all or any of the powers, authorities and discretions by or
under these Articles vested in or exercisable by the Directors generally.
- Power to delegate to Committees 122. The Board may delegate all or any of their powers to Committees consisting of such person or persons (whether a member or members of their body or not) as they think fit. All Committees so formed shall, in the exercise of the powers so delegated, conform to any regulations that may be imposed upon them by the Board. The meetings and proceedings of any such Committee consisting of two or more persons shall be governed by the provisions in these Articles contained for regulating the meetings and proceedings of the Board so far as the same are applicable thereto and are not superseded by any regulations made by the Board under this Article.
- Validity of acts 123. All acts done by any meeting of the Board, or of a Committee of the Board, or by any person acting as a Director, shall, notwithstanding it be afterwards discovered that there was some defect in the appointment of any such Director or person acting as aforesaid, or that they, or any of them were disqualified, or had vacated office or were not entitled to vote, be as valid as if every such person had been duly appointed and was qualified or had continued to be a Director and had been entitled to vote.
- 124. Resolutions in A resolution in writing signed by all the Directors except such as are writing absent from Hong Kong or temporarily unable to act through ill-health or disability (or their alternate Directors) shall be as valid and effectual as if it had been passed at a meeting of the Board duly convened and held. Any such resolution in writing may consist of several documents in like form each signed by one or more of the Directors or alternate Directors. A resolution signed by a Director and transmitted to the Company by post or facsimile transmission or electronic communication shall be deemed to be a document signed by him for the purpose of this Article. A notification of consent to such resolution given by a Director in writing to the Board by any means (including by means of electronic communication) shall be deemed to be his signature to such resolution in writing for the purpose of this Article.

Notwithstanding the foregoing, a resolution in writing shall not be passed in lieu of a meeting of the Board for the purposes of considering any matter or business in which a Substantial Shareholder or a Director has a conflict of interest and the Board has determined that such conflict of interest to be material. - Power to authenticate documents 125. Any Director or the Secretary or any person appointed by the Board for the purpose shall have power to authenticate any documents affecting the constitution of the Company and any resolution passed by the Company or the Board or any Committee of the Board and any books, records, documents and accounts relating to the business of the Company and to certify copies thereof or extracts therefrom as true copies or extracts; and where any books, records, documents or accounts are elsewhere than at the Office the local manager or other officer of the Company having the custody thereof shall be deemed to be the person appointed by the Board as aforesaid.
- Documents authenticated as above to be conclusive 126. A document purporting to be a copy of a resolution or an extract from the minutes of a meeting of the Board or of a Committee of the Board which is certified as such in accordance with the provisions of the last preceding Article shall be conclusive evidence in favour of all persons dealing with the Company upon the faith thereof that such resolution has been duly passed or as the case may be that such extract is a true and accurate record of a duly constituted meeting of the Board or of the Committee.
- Minutes 127. The Board shall cause minutes to be entered in books kept for the purpose of:
 - (A) all appointments of officers made by the Board;
 - (B) the names of the Directors present at each meeting of the Board and of any Committee of the Board; and
 - (C) all resolutions and proceedings at all meetings of the Company and of the holders of any class of shares in the Company and of the Board and of Committees of the Board.

Any such minutes if purporting to be signed by the Chairman of the meeting at which the proceedings took place or by the Chairman of the next succeeding meeting shall be evidence of the proceedings.

THE SECRETARY

- Appointment and removal of Secretary 128. Subject to the provisions of the Statutes a Secretary shall be appointed by the Board to hold office on such terms and for such period as they may think fit. Any Secretary so appointed may at any time be removed from office by the Board, but without prejudice to any claim for damages for breach of any contract of service between him and the Company. The Board may also appoint from time to time on such terms as they may think fit one or more Assistant or Deputy Secretaries.
- Authority of Assistant and Deputy Secretaries 129. Anything required or authorised by the Statutes to be done by or to the Secretary may, if the office is vacant or there is for any other reason no Secretary capable of acting, be done by or to any Assistant or Deputy Secretary or, if there is no Assistant or Deputy Secretary capable of acting by or to any officer of the Company authorised generally or specially in that behalf by the Board Provided that any provision of these Articles or the Statutes requiring or authorising a thing to be done by or to a Director and the Secretary shall not be satisfied by its being done by or to the same person acting both as Director and as, or in place of, the Secretary.

SEALS

- Safe custody 130. (A) The Board shall provide for the safe custody of the Seal and any Securities Seal and neither shall be used without the general or special authority of the Board or of a Committee of the Board authorised by the Board in that behalf and every instrument to which any such Seal (subject to the provisions hereof as to certificates for shares or debentures) is affixed shall be signed by a Director and shall be countersigned by a second Director or the Secretary or some other person duly authorised by the Board.
- Official Seal (B) The Company may have an official seal for use abroad under the provisions of the Statutes, where and as the Board may determine, and the Company may by writing under the Seal appoint any agent or agents, committee or committees abroad to be the duly authorised agent of the Company for the purpose of the fixing and using of such official seal and may impose such restrictions on the use thereof as may be thought fit. Wherever in these Articles reference is made to the Seal, the reference shall, when and so far as may be applicable, be deemed to include any such official seal as aforesaid.

The Board may, before recommending any dividend, whether preferential Power to carry profits to or otherwise, carry to reserve out of the profits of the Company reserve (including any premiums received upon the issue of debentures or other securities of the Company) such sums as they think proper as a reserve or reserves which shall, at the discretion of the Board, be applicable for any purpose to which the profits of the Company may be properly applied, and pending such application may, at the like discretion, either be employed in the business of the Company or be invested in such investments (other than shares of the Company, or of its holding company, if any) as the Board may from time to time think fit. The Board may also without placing the same to reserve carry forward any profits which they may think prudent not to distribute.
- Subscription132.132.132.Right Reserve132.(A)If, so long as any of the rights attached to any warrants issued by
the Company to subscribe for shares of the Company shall remain
exercisable, the Company does any act or engages in any transaction
which, as a result of any adjustments to the subscription price in

conditions of the warrants, would reduce the subscription price to
below the par value of a share, then the following provisions shall
apply:-[Reserved]

- (ii) that members will receive in lieu of such dividend (or such part thereof as the Board may think fit) an allotment of shares credited as fully paid provided that members are at the same time accorded the right to elect to receive such dividend (or part thereof as the case may be) in cash in lieu of such allotment. In any such case, the following provisions shall apply:-
 - (a) the provisions set out in sub-paragraphs (a), (b) and (c) of paragraph (i) above;

- (B) The shares allotted pursuant to the provisions of paragraph (A) above shall rank *pari passu* in all respects with the fully paid shares then in issue save only as regards participation in the relevant dividend (or share or cash election in lieu).
- (C) The Board may do all acts and things considered necessary or expedient to give effect to any capitalisation pursuant to the provisions of paragraph (ii) above, with full power to the Board to make such provisions as they think fit in the case of shares becoming distributable in fractions (including provisions whereby, in whole or in part, fractional entitlements are aggregated and sold and the net proceeds distributed to those entitled, or are disregarded or rounded up or down or whereby the benefit of fractional entitlements accrues to the Company rather than to the members concerned). The Board may authorise any person to enter into, on behalf of all members interested, an agreement with the Company providing for such capitalisation and matters incidental thereto and any agreement made pursuant to such authority shall be effective and binding on all concerned.

(D) The Board may on any occasion determine that rights of election under paragraph (A)(i) of this Article and the allotment of shares under paragraph (A)(ii) of this Article shall not be made available or made to any members with registered addresses in any territory where in the absence of a registration statement or other special formalities the circulation of an offer of such rights of election or the allotment of shares would or might be unlawful, and in such event the provisions aforesaid shall be read and construed subject to such determination.

Dividends 135. No dividend shall be payable except in accordance with the provisions of the Statutes or in excess of the amount recommended by the Board.

- Declaration and 136. Subject to the rights of persons (if any) entitled to shares with special rights as to dividend, all dividends shall be declared and paid according to the amounts paid up on the shares in respect whereof the dividend is paid, but no amount paid up on a share in advance of calls shall be treated for the purposes of this Article as paid up on the share. All dividends shall be apportioned and paid pro rata according to the amounts paid up on the shares during any portion or portions of the period in respect of which the dividend is paid except that if any share is issued on terms providing that it shall rank for dividend as if paid up (in whole or in part) as from a particular date such share shall rank for dividend accordingly.
- 137. Interim Subject to the provisions of the Statutes, the Board may if they think fit dividends from time to time pay to the members such interim dividends as appear to the Board to be justified by the profits of the Company available for distribution. If at any time the share capital of the Company is divided into different classes the Board may pay such interim dividends, in respect of those shares in the capital of the Company which confer on the holders thereof deferred or non-preferential rights as well as in respect of those shares which confer on the holders thereof preferential rights with regard to dividend, and provided that the Board act bona fide they shall not incur any responsibility to the holders of shares conferring any preference for any damage they may suffer by reason of the payment of any interim dividend on any shares having deferred or non-preferential rights. The Board may also pay half-yearly or at other suitable intervals to be settled by them any dividend payable at a fixed rate if they are of the opinion that the profits available for distribution justify the payment.

- Power to deduct debts due to Company
 (A) The Board may deduct from any dividend or other moneys payable to any member on or in respect of a share all sums of money (if any) immediately payable by him to the Company on account of calls or otherwise in relation to the shares of the Company held by him.
 - (B) The Board may retain the dividends or other moneys payable upon the shares in respect of which any person is under the provisions as to the transmission of shares hereinbefore contained entitled to become a member, or which any person is under those provisions entitled to transfer, until such person shall become a member in respect of such shares or shall transfer the same.
- Unclaimed 139. All dividends unclaimed for one year after having been declared may be invested or otherwise made use of by the Board for the benefit of the Company until claimed. If any divided shall have remained unclaimed for at least six years after the same became payable the Board may forfeit the same and after such forfeiture no member or other person shall have any right to or claim in respect of such dividend. No dividend shall bear interest against the Company.
- Joint holders 140. Any one of two or more joint holders may give effectual receipts for any dividends or other moneys payable or property distributable in respect of the shares held by such joint holders.
- 141. Method of Any dividend, interest or other sum payable in cash to the holder of payment shares may be paid by cheque or warrant sent through the post addressed to the holder at his registered address or, in the case of joint holders, addressed to the holder whose name stands first in the Register in respect of the shares at his registered address as appearing in the Register or addressed to such person and at such address as the holder or all of the joint holders may in writing direct. Every such cheque or warrant shall, unless the holder or all of the joint holders otherwise direct, be made payable to the order of the holder or, in the case of joint holders, to the order of the holder whose name stands first in the Register in respect of such shares, and shall be sent at his or their risk and payment of the cheque or warrant by the bank on which it is drawn shall constitute a good discharge to the Company. Subject to the consent of the Company, any dividend, interest or other sum payable in cash to the holder of shares may be paid, at the risk of the holder, by direct bank transfer or in such other manner as the holder or, in the case of joint holders, all of the joint holders may in writing request and compliance with such a request shall constitute a good discharge to the Company.

FULL TERMS OF THE NEW ARTICLES

Payment in specie

142. Any General Meeting declaring a dividend may direct payment of such dividend wholly or in part by the distribution of specific assets, and in particular of paid up shares or debentures of any other company, or in any one or more of such ways, and the Board shall give effect to such resolution, and where any difficulty arises in regard to the distribution they may settle the same as they think expedient, and in particular may issue fractional certificates and may fix the value for distribution of such specific assets or any part thereof and may determine that cash payments shall be made to any members upon the footing of the value so fixed in order to adjust the rights of all parties, and may vest any such specific assets in trustees upon such trusts for the persons entitled to the dividends as may seem expedient to the Board and may appoint any person to sign any instruments of transfer and any other documents deemed to be expedient by the Board on behalf of the persons entitled to the dividend and such appointment shall be effective and binding on all such persons.

CAPITALISATION OF RESERVES

Power to capitalise

143. The Company may by Ordinary Resolution, upon the recommendation of the Board and subject as hereinafter provided, resolve that it is desirable, with or without allotting and issuing new shares, to capitalise any part of the amount, for the time being standing to the credit of any of the Company's reserve accounts or distributable profits standing to the credit of the Company's statement of comprehensive income or otherwise available for distribution and not required for paying the fixed dividends on any shares entitled to fixed preferential dividends with or without further participation in profits any preferential dividend, for the time being standing to the credit of any of the Company's reserve accounts (including share premium account or capital redemption reserve) or any undivided profits of the Company (whether or not the same are available for distribution) and that the Board be accordingly authorised and directed to appropriate the sum or profits so resolved to be capitalised as capital to the members in the proportion in which such sum or profits would have been divisible amongst them had the same been applied or been applicable in paying dividends on the shares held by them on such date as shall be fixed by or in accordance with such resolution, and to apply such sum or profits on their behalf, either in or towards paying up the amounts, if any, for the time being unpaid on any shares or debentures held by such members respectively, or in the paying up in full of unissued shares or debentures of the Company to be issued to members of a nominal amount equal to such sum or profits, such shares or debentures to be allotted and distributed, credited as fully paid up, to and among such members in the proportion aforesaid, or partly in one way and partly in the other pProvided always that any the share premium account or capital redemption reserve accounts and any profits which are not available for distribution may, for the purpose of this Article, only be applied in the paying up of unissued shares to be issued to members as fully paid.

FULL TERMS OF THE NEW ARTICLES

144. Procedure on Whenever such a resolution as aforesaid shall have been passed the Board capitalisation shall make all appropriations and applications of the undivided profits or sum resolved to be capitalised thereby, and all allotments and issues of fully paid shares or debentures, if any, and generally shall do all acts and things required to give effect thereto with full power to the Board to make such provision by the issue of fractional certificates or by payment in cash or otherwise as they think fit for the case of shares or debentures becoming distributable in fractions and also to authorise any person to enter on behalf of all members entitled thereto into an agreement with the Company providing for the allotment to them respectively, credited as fully paid up, of any shares to which they may be entitled as the result of such capitalisation, and any agreement made under such authority shall be effective and binding upon all such members.

ACCOUNTS

- Books of account 145. The Board shall cause proper books of account to be kept in accordance with the provisions of the Statutes. Proper books shall not be deemed to be kept if there are not kept such books of account as are necessary to give a true and fair view of the state of the Company's affairs and to explain its transactions.
- Accounting 146. The accounting records shall be kept at the Office, or subject to the provisions of the Statutes, at such other place as the Board shall think fit, and shall at all times be open to the inspection of the officers of the Company but no member (not being such an officer) shall have any right to inspect any book, account or document of the Company, except as conferred by the Statutes, or authorised by the Board or by an Ordinary Resolution of the Company.

- (A) Subject to Article 149(B), a copy of the Relevant Financial Reporting Documents and/or a copy of the Summary Financial Report (where the recipient has, in accordance with and if required by the Statutes and other applicable laws, rules and regulations, consented or is deemed to have consented to receiving the Summary Financial Report in place of the Relevant FinancialReporting Documents) shall, not less than twenty-one clear days before the relevant General Meeting, be delivered or sent by post to the registered address of every Entitled Person and to the Auditors and the required number of copies of each of the Relevant Financial Report, if published, shall at the same time be forwarded to the Stock Exchange.
 - (B) Subject to the Company complying with the Statutes and any other applicable laws, rules and regulations from time to time in force with regard to any requirements for the obtaining of consent (or deemed consent) from any Entitled Person (a "Consenting Person") and/or for giving a Notice of Publication (as defined in Article 152) to any such Consenting Person, the Company may treat the publication of the Relevant FinancialReporting Documents and/or the Summary Financial Report (as the case may be) on the Company's eomputer networkwebsite, to which such person may have access, throughout the period beginning not less than twenty-one clear days before the relevant General Meeting, as discharging the Company's obligation to send to him a copy of such documents under Article 149(A). - Approval of 150. Every such statement of accounts when audited and approved by an Annual General Meeting shall be conclusive except as regards any error discovered therein within three months next after the approval thereof. Whenever any such error is discovered within that period the statement of accounts shall forthwith be corrected, and thenceforth shall be conclusive.

AUDIT

Auditors 151. (A) At the annual general meeting or at a subsequent extraordinary general meeting in each year, the Members shall, by way of <u>Ordinary Resolution</u>, appoint an auditor to audit the accounts of the Company and such auditor shall hold office until the next annual general meeting. Such auditor may be a Member but no Director or officer or employee of the Company shall, during his continuance in office, be eligible to act as an auditor of the Company.

- (B) The Members may, at any general meeting convened and held in accordance with these Articles, by special Ordinary Rresolution remove the Auditor at any time before the expiration of his term of office and shall by Θ rdinary Rresolution at that meeting appoint another Auditor in his stead for the remainder of his term.
- (C) The remuneration of the Auditor shall, by ordinary resolution, be fixed by the Company in general meeting or in such manner as the Members may by ordinary resolution determine.
- (D) A casual vacancy in the office of the auditor of the Company shall be filled in accordance with the requirements of the Statutes.

WINDING UP

Power of 159. If the Company shall be wound up the liquidator may, with the sanction liquidator to of a Special Resolution of the Company and with any other sanction distribute required by the Statutes, divide amongst the members in specie or kind assets in specie the whole or any part of the assets of the Company (whether they shall consist of property of the same kind or not) and may, for such purpose set such value as he deems fair upon any property to be divided as aforesaid and may determine how such division shall be carried out as between the members or different classes of members. The liquidator Power of may, with the like sanction, vest the whole or any part of such assets in liquidator to trustees upon such trusts for the benefit of the contributories as the vest assets in liquidator, with the like sanction, shall think fit, but so that no member trustees shall be compelled to accept any shares or other securities whereon there is any liability.

INDEMNITY

- 160. Indemnity of Subject to and so far as may be permitted by the Statutes, every Director, Directors and the Company Secretary or other officer of the Company shall be entitled Officers to be indemnified by the Company against all costs, charges, losses, expenses and liabilities incurred by him in the execution and discharge of his duties or in relation thereto including any liability incurred by him in defending any proceedings, civil or criminal, which relate to anything done or omitted or alleged to have been done or omitted by him as an officer or employee of the Company or Associated Company and in which judgment is given in his favour (or the proceedings are otherwise disposed of without any finding or admission of any material breach of duty on his part) or in which he is acquitted or in connection with any application under any Ordinance for relief from liability in respect of any such act or omission in which relief is granted to him by the Court.Subject to the provisions of the Statutes, every Director or other officer or Auditor for the time being of the Company shall be indemnified out of the assets of the Company against all costs, charges, expenses, losses and liabilities which he may sustain or incur in or about the execution or holding of his office or otherwise in relation thereto.
 - <u>161.</u> <u>Subject to and so far as may be permitted by the Statutes, the Company</u> may purchase and maintain for any officer of the Company:-
 - (A) insurance against any liability to the Company or any other party in respect of any negligence, default, breach of duty or breach of trust (save for fraud) of which he may be guilty in relation to the Company; and
 - (B) insurance against any liability incurred by him in defending any proceedings, whether civil or criminal, taken against him for any negligence, default, breach of duty or breach of trust (including fraud) of which he may be guilty in relation to the Company.
 - 162. Any indemnity permitted to be provided by the Company to the Directors under Section 469 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong) is subject to disclosure in the relevant Directors' report in accordance with Section 470 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong); and the Company shall keep in its Office a copy, or document setting out the terms of such permitted indemnity provision in accordance with Section 471 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong) which shall be made available for inspection by any Shareholder subject to Section 472 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).
